A system for citing Anglo-Saxon charters

Anglo-Saxon charters are cited conventionally by their number in P. Sawyer, *Anglo-Saxon Charters: an Annotated List and Bibliography*, Royal Historical Society Guides and Handbooks 8 (London, 1968), abbreviated as S, followed by the number in the catalogue (e.g. S 876); but, as a matter of good practice, it is helpful if the reference can also incorporate an indication of the edition cited and of the 'archive' in which it was preserved.

When complete, the new edition of the surviving corpus of charters, prepared under the auspices of the British Academy / Royal Historical Society Joint Committee on Anglo-Saxon Charters, will comprise about 30 volumes, each containing the charters formerly preserved in the archives of a particular religious house, or group of houses. A revised edition of 'Sawyer' has been prepared and is being maintained as part of the same project. The data in the 'Revised Sawyer' is available online as the 'Electronic Sawyer'. In those cases where a charter is from an archive which has already been published in the new edition, the charter can be cited by its number in 'Sawyer', followed in brackets by a standard form of abbreviation for the volume in question (which of its nature serves also as an indication of the archive), e.g. S 876 (*Abing* 124). In those cases where a charter is from an archive which has not yet been published in the new edition, it would be necessary to give its number in Birch's edition (for the period to 975), or in Kemble's edition (for the period 975–1066). Charters forming part of the Crawford collection, in the Bodleian Library, should be cited in these circumstances from *Crawford Charters*, ed. Napier and Stevenson. Vernacular texts, which may be available in Birch or Kemble, though not yet in the new edition, should be cited from the series comprising Harmer's *SEHD*, Whitelock's *Wills*, Robertson's *Charters*, and Harmer's *Writs*.
